A motion to revise The Stormwind Law to have a new paragraph about the trade of body parts of a Sentient Species.

## Definitions

**The Stormwind Law** - The current law book written by the Ministry of Justice for application of criminal justice in the Kingdom of Stormwind.

## Revisions

Chapter 2, Section 2 has Paragraph 8 added with a Grade 2 Severity which reads;

- §8 - Trade in Body Parts of Sentient Species  
A person is guilty of Selling Body Parts of Organs if they knowingly sell any part of the body, inside or outside, belonging to a Sentient Species.

Chapter 2, Section 2, Paragraph 8 has as the following additional information sections added to it;

- Medical Malpractice: A person may be found guilty of Medical Malpractice in addition to Selling Body Parts or Organs of Sentient Species. A person may be guilty of Medical Malpractice when Selling Body Parts or Organs of Sentient Species even if they hold a medical license in the Kingdom of Stormwind.
- Sentient Species: Sentient species in the context of the law are species with the capacity for feelings, considered self conscious and capable of communication. Excluded from that definition are Entities from different planes of Existence (such as Elementals), Demons and Undead (Excluding Forsaken, Dark Rangers and Death Knights of the Ebon Blade). Sentient Species are granted the following base rights:
  - A right for freedom
  - Protection from torture
  - Protection from slavery
  - A right to be trialed by Stormwind Law

In Order to keep the peace, Sentient Species that are not Members of the Alliance may be removed from Alliance Territories or arrested if they cause trouble or distress. Law Enforcement Officials are to use force if met with hostility.

- Disturbing the Dead: A person charged with Selling of Body Parts or Organs of Sentient Species can also be found guilty of Disturbing the Dead if found to have gotten the parts or organs through graverobbing. Sold remains from archeological excavations to legit and licensed archeological organisations would not be considered Disturbing the Dead.
- Body Parts & Organs: When talking about body parts & organs of sentient species the following will be considered illegal to trade in the Kingdom of Stormwind;
  - Any limb(s) belonging to a Sentient Species
  - Any organ(s) belonging to a Sentient Species
  - The skin of a Sentient Species, including Worgen fur

Chapter 2 has the following Definition added;

- Body Parts & Organs: When talking about body parts & organs of sentient species the following will be considered illegal to trade in the Kingdom of Stormwind;
  - Any limb(s) belonging to a Sentient Species
  - Any organ(s) belonging to a Sentient Species
  - The skin of a Sentient Species, including Worgen fur
