Summary

Adding Chapter 7 - Transportation and Maintenance Act

Definitions

The Stormwind Law - The current law book written by the Ministry of Justice for application of criminal justice in the Kingdom of Stormwind.

Transportation and Maintenance Act - A motioned act which defines the laws in regards to any sort of transportation, be it mechanical or non-mechanical, as well as permits in regards to construction

Revisions

- Adds Chapter 7 to The Stormwind Law with the following information
 - §1 Use of an Illegal Vehicle or Mount at Grade 4
 - §2 Reckless Driving/Riding at Grade 5
 - §3 Blocking Critical Infrastructure at Grade 5
 - §4 Construction Without Permit at Grade 3

- Chapter 7, §1 Use of an Illegal Vehicle or Mount is added with the following
 - A person is guilty of the Use of an Illegal Vehicle or Mount if they use one of the defined illegal vehicles or mounts within the Kingdom of Stormwind.
 - The following "Additional Information" is added to the paragraph; Various mounts and vehicles are illegal to use within the Kingdom of Stormwind, these include but are not limited to the following;
 - Mechanical Vehicles made for Warfare or that pose a general danger to the public, like Shredders, Mechs, Steamtanks etc.
 - Mounts that pose a general danger to the public
 - Undead Mounts not in possession of the Ebon Blade.
 - Demonic Mounts not in possession of the Illidari
 - Void Entity Mounts not in possession Ren'dorei
- Chapter 7, §2 Reckless Driving/Riding is added with the following
 - A person is guilty of Reckless Driving/Riding if using their method of transportation, be it a non-mechanical or mechanical mount, at unsafe speeds or in a reckless manner throughout a city or a town.
 - The following extra aggravating circumstances are added to this paragraph
 - Under the influence of alcohol or drugs
 - Driving in non-vehicle areas
 - Driving towards a crowd of people
- Chapter 7, §3 Blocking Critical Infrastructure is added with the following
 - A person is guilty of Blocking Critical Infrastructure if they block bridges, streets or other critical infrastructure with vehicles, mounts or otherwise.
- Chapter 7, §4 Construction Without Permit is added with the following
 - A person is guilty of construction without License if they engage in work that adds to, alters or destroys property of Cities, Towns or Infrastructure of the Kingdom without License to do so.
